The Government of the Republic of Suriname has received financing from the Inter-American Development Bank (IDB), and it intends to apply part of the proceeds to payments under the project **Support to Improve Sustainability of the Electricity Service, for the procurement of steel or concrete poles for 33kV Transmission Lines.**

The N.V. Energiebedrijven Suriname (EBS) now invites sealed bids from eligible bidders for the delivery of steel or concrete poles to Paramaribo Suriname as specified in the schedule for the delivery of the goods in the bidding document. Bidding will be conducted through international competitive bidding procedures as specified in the Inter-American Development Bank's [Policies for Procurement of Works and Goods financed by the Inter-American Development Bank](#) G/N 2349-9 (current edition), and is open to all eligible bidders as defined in the policies.
