The *Republic of Suriname* has received financing from *the Inter-American Development Bank (IDB)*, toward the cost of the “*Support to Improve Sustainability of the Electricity Service*” and “*Support to the Implementation of EBS’ Investment Plan,*” and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) includes support for the ERP, GIS, SCADA, OMS/DMS, Energy Efficiency, and EBS transition projects that are currently in execution at an electric utility company.

The services are expected to be provided as of March 1, 2017 with a duration of 24 months.

N.V. Energiebedrijven Suriname now invites eligible Individual Consultants to indicate their interest in providing the Services. Interested Individual Consultants shall submit an application composed by: (i) an application letter; and (ii) a Curriculum Vitae; demonstrating that they have the required qualifications and relevant experience to perform the Services as reflected in the Terms of Reference.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: *Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank* GN-2350-9 and is open to all eligible Individual Consultants as defined in the policies. A Consultant will be selected in accordance with the method set out in the Consultant Policies Section V “Selection of Individual Consultants”.
