Tenders must be accompanied by the following:-

- Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for submission of bids. (Local Firms).
- Valid Certificate of Compliance issued in accordance with the National Insurance Act. (Local Firms).
- Certified Bank Statement
- Certificate of Incorporation

All bids must be accompanied by a Bid Securing Declaration

The original tender and six (6) copies must be submitted in sealed envelope(s) clearly marked:-
