The Inter-American Development Bank (IDB) is executing the above-mentioned operation. For this operation, the IDB intends to contract consulting services described in this Request for Expressions of Interest. Expressions of interest must be delivered using the IDB Portal for Bank Executed Operations (<http://beo-procurement.iadb.org/home>) by: *July 29, 2022*, 5:00 P.M. (Washington D.C. Time).

To access the IDB Portal, the firms must generate a registration account, including **all** the data requested by the Portal. In the event that any of the information requested is not included, the firm will not be able to participate in this or any other Bank-executed selection process for operational work. If the firm has been previously registered, please validate that you have **all** the firm's information updated and complete before submitting an expression of interest.

The consulting services ("the Services") include:

- Analyze, design, develop and test, the web-based ConnectAmericas CAFTA-DR Textiles Directory (TD) ensuring the implementation of a user-centered design approach, usability, availability, performance, scalability, and security.
- Analyze and document functional and technical requirements to meet the software features described in Table 0-1.
- Validate user stories with real potential users (suppliers and importers) of the platform.
- Produce mock-ups, obtain feedback from users, and propose the user experience that best meets the business requirements described in Table 0-1.
- Propose the solution software architecture according to the suggested technologies listed in Table 0-2.
- Implement frontend and backend development activities according to the design and software architecture approved by the CA's team.
- Implement the required integrations with the ConnectAmericas platform, considering CA's webservices described in Table 0-3. To use these services, an authentication token is required, and consumption is done via GET and POST HTTP requests.
- Carry out quality assurance of the features developed, including Regression, Integration, Smoke, Automatic and Stress (if it applies) tests.

Other considerations:

- Consultancy firm should provide development and testing environments.
- Pre-production and Production environments will be provided by the CA's teams. Solution will be hosted in ConnectAmericas AWS Infrastructure according to components described in Figure 1.
- Solution should be available in English and Spanish.
- Lead and participate actively in Planning, Review, Retrospective and Daily meetings according to SCRUM framework.
- Configure the JIRA management tool within the CA's account.
- Solution must include Google Analytics.

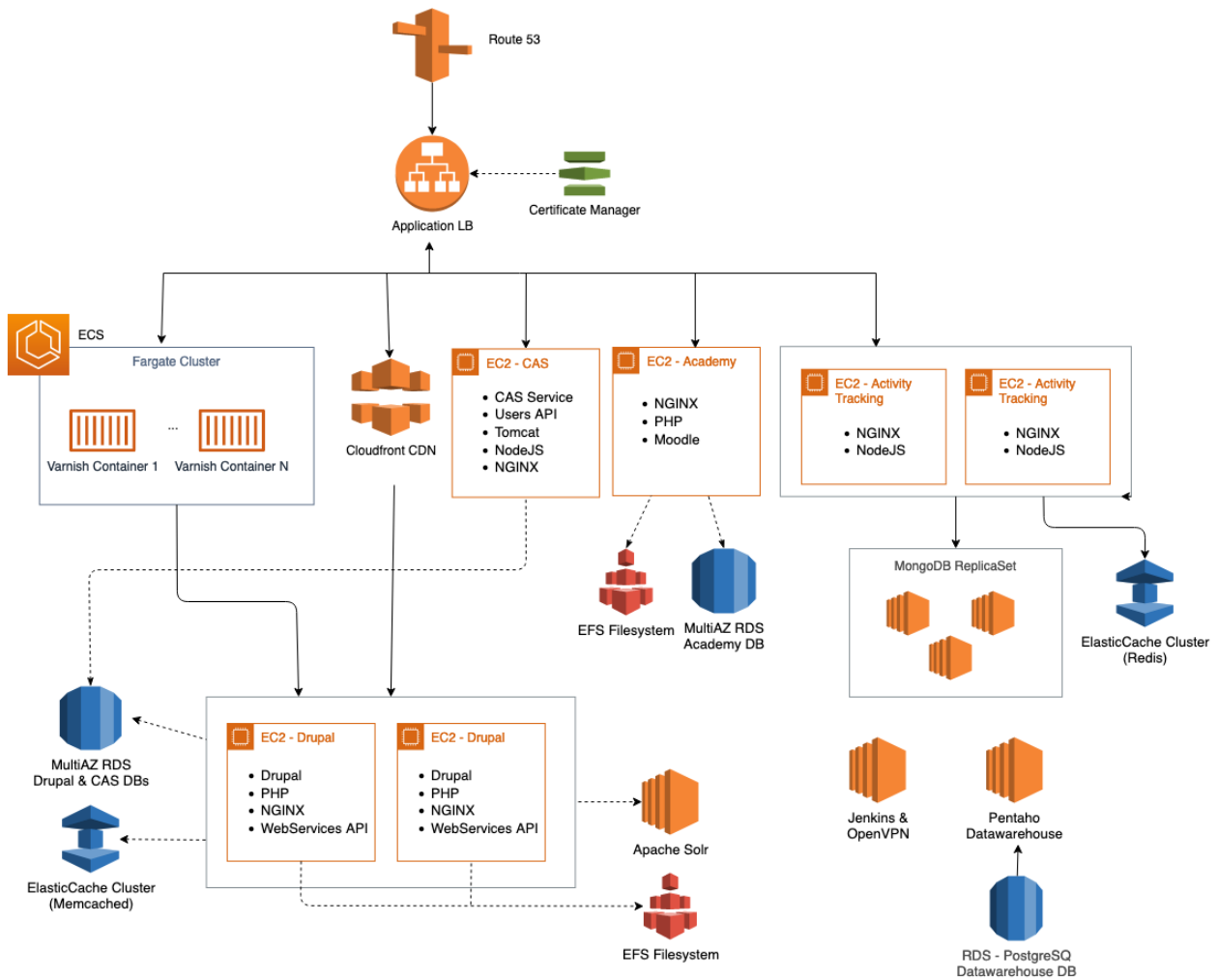

Company	Retrieves the list of companies registered in ConnectAmericas, a company profile and allows to search for products and services. Search filters are by language, country, and organization type.
Country	Retrieves the list of countries registered in ConnectAmericas.
Industry	Retrieves a list of industries used in ConnectAmericas. Information can be filtered by language (ES, EN, PT).
Business opportunity	Retrieves the list of business opportunities registered in ConnectAmericas and the details of a specific business opportunity. Search filters are by language, country, and industry.
Content	Retrieves contents (articles, videos, business support services) created in CA.



Key Activities

- Analysis
 - User stories analysis and validation with CA's team and other key stakeholders.
 - Identify business scenarios and users' journey.
- UX Design
 - User persona mapping and definition
 - User experience design.
 - Prototypes design and users' feedback collection.
- Implementation
 - Solution architecture compatible with AWS and suggested technologies as per Table 0-2 and Figure 1.
- Quality assurance. Test cases identification, unitary, integration and user acceptance tests.
- Hypercare. Support and maintenance should be provided through one month post go-live.
- Transfer to CA's support team.

Expected Outcome and Deliverables

- The consulting firm shall provide the following products:

- Working functionality code deployed within ConnectAmericas live environment.

- Final report indicating the activities executed and including the contracted services.

Such association or Joint Venture shall appoint one of the firms as the representative.
